Notice of Adoption of the Joint Minerals and Waste Plan

In accordance with Regulations 26 and 35 of the Town and Country Planning (Local Development) (England) Regulations 2012 (as amended), notice is hereby given that Wokingham Borough Council adopted the Joint Minerals & Waste Plan on 19th January 2023.

Bracknell Forest Council, Reading Borough Council, Royal Borough of Windsor & Maidenhead and Wokingham Borough Council (the 'Central & Eastern Berkshire Authorities') resolved separately to adopt the Joint Minerals & Waste Plan at their respective Council meetings on following dates:

- Bracknell Forest Council 11 January 2023
- Reading Borough Council 31 January 2023
- The Royal Borough of Windsor & Maidenhead 22 November 2022
- Wokingham Borough Council 19 January 2023

The Joint Minerals & Waste Plan is the principal document for the management of minerals and waste in the administrative areas of the Central & Eastern Berkshire Authorities and sets out the long-term spatial vision and strategies for sustainable minerals and waste development in Central and Eastern Berkshire up to 2036.

Independent Inspectors appointed by the Secretary of State, considered the Joint Minerals & Waste Plan during an Examination which involved public hearings held in two stages on 28 – 30 September 2021 and 12 October 2021.

The Inspector's Report, with its recommendations, was received by the Central & Eastern Berkshire Authorities on 21 October 2022 and was published online¹. The Report concluded that the Local Plan is sound and legally compliant, subject to the incorporation of final Main Modifications recommended by the Inspectors as set out in the Appendix to the Report. These Main Modifications together with consequential additional modifications are incorporated in the adopted Local Plan and shown on the Policies Map.

The Joint Minerals & Waste Plan supersedes the saved policies in the Replacement Minerals Local Plan for Berkshire (2001) and the Waste Local Plan for Berkshire (1998) in the administrative boundaries of the Central & Eastern Berkshire Authorities.

Any person aggrieved by the adoption of the Joint Minerals & Waste Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that the document is not within the appropriate powers and/or a procedural requirement has not been complied with. Any such application must be made no later than the end of the six-week period starting with the day after the date of adoption (19 January 2022). The challenge period for Wokingham Borough Council ends on 3 March 2023.

Copies of the adopted Joint Minerals & Waste Plan and associated documents, including this Adoption Statement, Sustainability Appraisal (incorporating Strategic Environmental Assessment) Post-Adoption Statement and Habitats Regulation Assessment Record will be available for inspection on the website². Alternatively, documents will be available for inspection (during normal office hours) at the Council Offices, Shute End, Wokingham, RG40 1BN, shortly after the publication of this notice.
