

## THE RIGHT OF APPEAL

You have the right of appeal against the decision not to allocate a place at a preferred school. This is because the school is full with children who ranked higher in accordance with the school's oversubscription criteria detailed in the Parent's Guide. Please read the statement of the allocation for appeal purposes provided for schools in the Wokingham borough. Similar information may be published for **schools outside the borough** on the respective local authority website.

An independent appeals panel will be formed to consider any appeals, convened in accordance with the School Admissions Appeals Code. An appeals form and information leaflet can be obtained from the relevant admissions authority that has responsibility for the school being appealed for or as detailed in the admissions policy for the school. Please submit your appeal form by the deadline shown. Appeal forms received after this date will be accepted, but there may be some delay in hearing the appeal. Parents who make formal appeals will be invited to attend the hearing.
