School Governor, Coombes	I am writing in my capacity as a Local Governing Body member at the Coombes C of E Primary regarding the Farley Hill School Proposal and expansion of places in Arborfield. I want to express my concern at the Council's recommendation to add more primary places when the Coombes currently as more than enough capacity to take on the expected number of primary places needed for a number of years. The Coombes also has an extensive site and grounds that would provide a great setting for new families moving to Arborfield Green. Surely it makes sense to invest in the schools we already have established in the community and filling them before building new premises? I fear that the Council's current proposal could be detrimental to the Coombes and its future, causing even more competition within the local area and affecting jobs and stability for members of the Coombes community. I implore the Council to reconsider this plan and to consider supporting existing local schools to fill all of the places available in their PAN before expanding the number of primary places within Arborfield.	As noted below (point A) the initial action, the relocation of the Farley Hill School, is unlikely to have a significant impact on the Coombes, but any future expansion must take account of the Coombes. The Coombes does serve Arborfield Green / Garrison residents and this is expected to continue to be the case. Expansion on the current Coombes site would be challenging, because there is no obvious way to mitigate additional car journeys (without adding to burdens on the home to school transport budget)

Commentary on frequently raised issues:

A) That the rolls of other schools will suffer if the new school opens.

It is proposed that Farley Hill School will initially transfer to the new site, retaining its current admission number. While the current admission number (30 per year) is retained, and because Farley Hill School is oversubscribed (and already draws most of its roll from Arborfield Green and its associated communities) there is no good reason to think other schools will see reduced rolls as a result of the proposal.

It will be important to ensure that the interests of all stakeholders are balanced, when the proposed expansion dates are reviewed, though. This process will need to weigh a number of factors, including

- the interests of Arborfield Green residents (who are likely to prefer that the school on the Arborfield Green site expands to meet local needs),
- the likelihood that those Arborfield Green parents who have placed children in Finchampstead schools, will prefer to place younger siblings in the same schools,
- protecting education provision that will serve the garrison and associated communities in the long run (with particular reference to the Coombes CoE School),
- protecting the interests of the schools that some garrison area residents use in the wider community (noting that these schools are not within walking distance of all homes, and most children from the Arborfield Green area would be driven to them),
- wider impacts on the community, including on traffic levels and the carbon footprints of alternatives...

B) That the analysis of local need should take the Finchampstead Schools into account

Point A) above covers the need to do this, at the point the expansion of Farley Hill needs to be reviewed.

The background information document dealt with this issue:

"Other schools are also attended by Arborfield Garrison SDL resident children, including Gorse Ride (Infant) and Finchampstead CoE Primary. These are though small proportions of both these schools rolls and of the Arborfield Garrison SDL resident population. Finchampstead CoE primary is only accessible by vehicle and the Gorse Ride Schools are over 1.2 miles (by safe walking routes) from the closest point on the edge of the Garrison area. The likelihood of either of these schools being ones that significant numbers of Arborfield Garrison residents would walk to is therefore low."

The key issue, for the long term is what should the long-term provision look like? Could this be based on an assumption that a significant number of Arborfield Garrison / Arborfield Green residents should look to the Finchampstead schools for their primary school places? The analysis underpinning the expansion case is based on the long established South West Primary Schools Planning Area, which includes Shinfield, Arborfield Green and surrounding communities (Barkham, Arborfield Cross and Arborfield) and Swallowfield. Planning areas are though just tools used to break the borough down into manageable units. While they are largely based on discernible communities, in practice there is always movement across planning area boundaries, reflecting parental preference and the availability of school places. It is reasonable therefore to consider if schools in the adjoining South-East

area (which includes Finchampstead) could provide at least part of the need generated by the growth of Arborfield Green. Until recently there was no usable pedestrian link between Finchampstead and Arborfield, but there are now two such routes, a footpath link from Nine Mile Ride and a surfaced, lit "Greenway" to the north of California Country Park. For homes in the north-west corner of Arborfield Green, the Finchampstead schools are the closest schools. There a number of good reason why this would be problematic, though:

Firstly, parents generally prefer local schools, unless they have specific concerns about school standards. Most responses from local parents (see above) strongly support having local schools in the Arborfield Green development.

Secondly, the council has made a long-term commitment to ensuring that all SDL communities are where practical, served by their own infrastructure, including schools, through the adopted Core Strategy. The Arborfield Primary Schools have been part of the long-term plans for the area, and are embodied in the statutory land use plans for the community.

Thirdly, the most recent Primary School Places Strategy (adopted by the Council's Executive in June 2018) emphasises the need to ensure that school places are focused on need, and states that there may be a need "to rationalise provision in other areas to ensure schools are sustainable". The adopted strategy is therefore to adjust provision to match local need, not to move the child population around the borough to match current provision.

Fourthly, if increased numbers of Arborfield Green children were to use Finchampstead schools this would lead to a significant increase in traffic volume on roads in Finchampstead (Barkham Ride and Nine Mile Ride). Only a minority of Arborfield Green homes are within statutory walking distance for Key Stage 1 children of any of the Finchampstead schools, with even the closest homes 1.2 miles away from the closest school. Most Arborfield Green children do not live within statutory walking distance (2 miles for under 8s) of these schools. In practise, it is likely that most children would be driven in by car. The DfT's National Travel Survey 2014: School Travel showed that where children live less than 1 mile from a school 79% of them walk to school, where they live between 1 and 2 miles, 72% travel by car, and when they live further than 2 miles, 90% travel by car¹.

The measurement (1.2 miles) is to the closest point on the new Arborfield Green community (Archer Grove), and consequently only the north eastern part of the Arborfield Green / garrison area is within statutory walking distance for Key Stage 1 children (under 8s). Kelvin Close, for example, on the west side of the community is 2.5 miles from the Gorse Ride Schools via this route

(and 2.8 miles via Nine Mile Ride). The Bohunt School Wokingham's site is 1.8 miles via Nine Mile Ride (so most homes immediately to the north and west of the Bohunt School site are further than 2 miles away).

It should also be noted that the Gorse Ride Schools are the closest schools, and most other Finchampstead schools are significantly further away. Nine Mile Ride School is 0.4 miles and St Sebastian's is 2.2 miles walking distance from the Gorse Ride Schools (so St Sebastian's is beyond statutory walking distance for children of all ages of Arborfield Green homes). Finchampstead CoE Primary School is 2.6 miles from the Bohunt School site, so is beyond statutory walking distance for children under 8, and also for children over 8, for most of the Arborfield Green / garrison areas. This is academic though, as there are no safe walking routes between Finchampstead Village and the Arborfield Green community.

Fifthly, if children are placed in Finchampstead Schools because there are no places available in local schools and they live further than statutory walking distance, they will be eligible for free home to school transport, increasing the burdens on the home to school transport budget (£10Ks on the basis that public transport is available).

C) That the analysis of needs should take place availability across all Wokingham Schools into account.

Extending the needs analysis to take account of all surplus capacity across the borough would undoubtedly mean that any additional provision in the Arborfield Green area would be delayed, and might never the required at all. Most of the points against this proposal are already set out in section B above relating to Finchampstead Schools, but the dislocation implied by having homes in a new community and places scattered across the borough (noting that Arborfield Green residents would only be able to access the less popular schools in each community, because of the operation of oversubscription criteria) would be markedly more problematic. This would be:

- a major breach of the commitments made by the council,
- would generate significant opposition by parents (when they were unable to secure places at preferred schools)
- add high volume of additional traffic across a wider area
- significantly increase spend on home to school transport (£100Ks, on the basis that a number of low occupancy vehicles would be needed to ferry children round the borough).

D) The submission by the Keys Trust

Most of the points made are covered above. However, there is a specific proposal that the Coombes could "revert to its previous PAN of 90" and that "This would create an additional 105 new spaces on top of the existing surplus capacity of 107, and so generating

212 additional spaces in total". The Trust claims that the relocation of the Farley Hill School would have "a significant detrimental effect on the pupil numbers at The Coombes and hence reduce funding even further". No explanation is given though as to why this should be the case (although other responses are that making the Farley Hill School more accessible will mean that the number of Arborfield Garrison / Green parents expressing a preference for that school will increase, so . They state that their proposal "has significant benefits to not only The Coombes, but to Wokingham Borough Council and new families moving in to the area". Eight specific benefits are listed, and these are set out below with a brief commentary:

1) Supporting an existing school with this additional capacity would safeguard against a multi-academy trust working against the interests of education across the Wokingham Borough as is being experienced in the secondary sector.

Comment: the current proposal does not involve an Academy Trust.

2) One of the weaknesses identified in the consultation document is responding quickly to changes in pupil numbers to meet demand of new families. The extensive school grounds at The Coombes are more than adequate to accommodate additional buildings should they become necessary. Within the last ten years, The Coombes benefited from investment in its Key Stage 2 buildings and as an academy within The Keys Academy Trust, the Trust will bid for Condition Improvement Funding to complete the rationalisation of the premises should this be required.

Comment: This is highly problematic, as set out below under the heading of "challenges of expanding provision on the Coombes site".

3) One of the challenges of the surplus capacity at The Coombes is the number of children that are diverted from Reading Borough Council. Since September 2019 there have been 38 number of children which have been diverted to The Coombes. These are generally short term placements and this mobility is disruptive to both the existing pupils and teachers and more importantly masks the surplus capacity for families moving into the Arborfield area.

Comment: this is true, but it is not clear what relevance it has (see "challenges of expanding provision on the Coombes site below", particularly as most diverted children are older children in Key Stage 2.

4) When new families move into the area, The Coombes will be able to offer places across the year groups until full to capacity which will reduce the travel disruption. This however would not be the case if as the consultation suggests, "total capacity in the Arborfield area can be "frozen" to ensure that the new premises do not create high levels of surplus places in local schools. This would be damaging to the education of children on the rolls of the schools with reduced rolls".

Comment: The Coombes has a current capacity of 525 places, and any unfilled places can be offered to any child whose parent wishes to secure a place at the school, irrespective of the council's proposal for the relocation of the Farley Hill school. Place availability at the Coombes will be reviewed when the expansion decision is reviewed. See also "challenges of expanding provision on the Coombes site" below.

5) Additional funding gained through increased pupil numbers will secure the future of The Coombes.

Comment: Increased pupils numbers would benefit the school, but the current admission numbers point to a sustainable future for the school.

6) The Keys has already secured rapid improvements at the school as evidenced by the Local Authority Review in December 2019. By supporting the existing school it creates confidence in the local authority from the parent community.

Comment: The improvements are noted. The real challenge for the Coombes is parental confidence in the school (see "challenges of expanding provision on the Coombes site").

7) Although both The Coombes and Farley Hill primary schools are used by children living in the Arborfield Garrison area, neither has good walking accessibility. However, The Coombes is on the edge of the neighbouring Arborfield Cross community and is within statutory walking distance (for children under the age of 8) of the northern part of the Arborfield Garrison SDL. Although Farley Hill is a similar distance from the new community, there are no safe walking routes from the Arborfield area to where Farley Hill is currently situated.

Comment: Relocating the Farley Hill School would resolve the accessibility issue for Arborfield Green residents.

8) The deferral allows Wokingham Borough Council to only open a new school once demand is guaranteed. The deferral of opening the primary school in Arborfield may release growth funding for existing pupils within WBC.

Comment: Firstly, the council is building the school premises, this proposal is only concerned with how it should be managed. Secondly, the construction contracts for new premises have to be let about two years before the school opens. Waiting until "demand is quaranteed" would inevitably lead to late delivery of the new school.

Challenges of expanding provision on the Coombes site

There are two principle concerns with expanding the school:

- That there are significant challenges to the expansion proposal made by the school.
- That it is far from clear that this what parents would want.

The Trust states that the school could revert to offer 90 places, as was previously the case. However, prior to academy conversion the school was formed from the amalgamation of two schools, with different admission numbers. On amalgamation the expectation was that the new school would offer 90 places (and 90 places were duly offered for a number of years). However, during the development of the works package, intended to ensure the new school had the facilities for its final size, the decision was taken to model the school to accommodate 525 pupils / 75 per year. At that time additional accommodation and staff car parking was provided, in line with the new capacity of 525 children (plus the nursery). Increasing the capacity to 630 places would require additional teaching accommodation, external play space, staff car parking, and improved drop off arrangements (noting that most Arborfield Green residents would in fact, drive their children to the school, because the Coombes will be more than 1 mile from their homes). The site is on the side of a hill and is heavily wooded, so there are development constraints. Additional staff car parking could be provided, by encroaching on the school's playing field. There is no obvious way additional parent drop-off space could be created (and parent drop off is a long standing, significant issue for the Arborfield Cross community). However willing the school might be to expand, there is no guarantee that planning permission could be obtained.

The other challenge, is that despite the school's improvement since its conversion to Academy status, it continues to be a school with a low number of applications, relative to the number of places available. This is despite there being sufficient demand in the immediate area of the school to largely fill it. This year (in the admissions round for September 2020 start) 65 children were offered places at the school. However, 17 of these were children who could not be allocated a preferred school. Nine of these came from the local area (Barkham / Arborfield and Newland Parishes) and some of these parents did not list the school, despite not using all their four preferences. The closest neighbourhhods (LSOAS) Arborfield and Barkham alone between them had 64 children allocated primary school places, with 25 (39%) allocated places at the Coombes. The Arborfield Garrison neighbourhood (LSOA) had 27 children allocated primary school places, with just under half (12) allocated places at the Coombes, the remainder being scattered across 10 other schools. This does not give confidence that Arborfield Green parents would opt for the Coombes, and while capacity exists in other schools, would lead to a significant increase in vehicle movement across the borough.

	Finally, we are aware that a new primary school is planned for Finchwood Park, the southern part of the Arborfield SDL which lies within Finchampstead. As noted above this development is underway with some properties occupied. The timing of the construction of the new Finchwood Park school should be taken in to account as part of this appraisal. If pending delivery of this school a significant number of children from the Finchwood Park development attend the new Arborfield Green school, the new Finchwood Park school could have significant spare capacity which would adversely impact the existing Finchampstead Schools. We appreciate that this may be some years off, but feel it is still relevant here.	for Reception places is seen in the new communities in the SDL areas. These children could otherwise attend other schools, helping maintain their viability. That said, unless the schools attended are immediately associated with the new community, relying on places in these schools will increase the level of school run traffic. Two of the three Finchampstead school settings (the Gorse Ride schools and Nine Mile Ride) are within walking distance of the garrison by safe routes for some parts of the new development. However, the shortest route to a Finchampstead school, from the edge of the Arborfield Green area, via the new Greenway is 1 ¼ miles. Given this, most Reception age children coming from the Arborfield Green area would be expected to be driven to school, adding to local traffic volumes at peak hours. Otherwise, future use of housing figures will make it clear that the data refers to the Arborfield Garrison SDL, and not the Arborfield and Newland Parish area.
