PUBLIC PATH CREATION ORDER

HIGHWAYS ACT 1980 SECTION 26

THE WOKINGHAM BOROUGH COUNCIL (JUBILEE AVENUE BRIDLEWAY WOKINGHAM) ORDER 2021

THIS ORDER is made by the Wokingham Borough Council ("the Council") under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that having regard to the matters set out in section 26(1) of the 1980 Act there is a need for a public bridleway described in Part I of the Schedule to this Order and it is satisfied that the bridleway will add to the convenience and enjoyment of a substantial section of the public and has considered the effect which the creation of the bridleway will have on those with an interest in the land.

The Council will defray the expenses incurred in bringing the new site of the bridleway into a fit condition for use by the public.

The Wokingham Town Council has been consulted in relation to the making of this Order as required by section 26(3) of the 1980 Act.

BY THIS ORDER:

- There shall be on the date of confirmation of this Order a public bridleway over the land situated adjacent to Jubilee Avenue, Wokingham and described in Part I of the Schedule to this Order and shown by a bold broken line on the map attached to this Order.
- 2. Notwithstanding anything contained in Paragraph 1 of this Order, where immediately before the date of this Order there is apparatus in, under or across the land belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers continue to have the same rights in the respect of the apparatus which they then had.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.
