STATUTORY DECLARATION
SECTION 31(6), HIGHWAYS ACT 1980**

I, DANIEL G. M. GRIST, Secretary to the Trustees and Stewards of Henley Royal Regatta DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Trustees of the Stewards of Henley Royal Regatta, are and have been since 1938 (Regatta Headquarters Car Park), 1939 (Lion Meadows), 1939 (Blandy Meadows), 1948 (Selwyn's Field), 1951 (Butler's Field), 1958 (Green's Field) 1969 (Barn Cottage) 1904 and 1983 (Regatta Headquarters) the owner within the meaning of Section 31 (6), Highways Act 1980 of the land known as **Regatta Headquarters Car Park, Lion Meadows, Blandy Meadows, Selwyn's Field, Butler's Field, Green's Field, Barn Cottage and Regatta Headquarters, Henley-on-Thames, Oxfordshire**, more particularly delineated on the plan to a scale of 1:7,500 accompanying this statement and thereon edged red.
2. On 12th December 2007 I deposited with Wokingham Borough Council, being the appropriate Council, a Statement accompanied by a plan delineating The Trustees of the Stewards of Henley Royal Regatta's property by red edging which stated that no ways had been dedicated as highways over their property other than Remenham 4 Footpath indicated in green on the accompanying plan (being subject to the ruling of the Appeal Committee of the Berkshire Court of Quarter Sessions held on the 11th June 1957), Remenham 7 Footpath indicated in pink on the accompanying plan and Remenham 8 Footpath indicated in brown on the accompanying plan. Receipt of the Statement and plan was acknowledged by letter 18th December 2007, a copy of which is attached.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this Declaration since this Statement dated 12th December 2007 referred to in paragraph 2 above and at the present time delineating The Trustees of the Stewards of Henley Royal Regatta have no intention of dedicating any more public rights of way over their property.

AND I MAKE this solemn Declaration on the 14th day of March 2008 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.
