Statutory Declaration

Section 31(6), Highways Act 1980

I Kenneth McDiarmid as agent authorised on behalf of The Englefield Trust Corporation (*landowner*) DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Englefield Trust Corporation is and has been since 20th October 1986 the owner of the land known as Part of the Englefield Estate, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 27th day of May 2011 I Kenneth McDiarmid deposited with Wokingham Borough Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that *the ways coloured broken blue on the said plan had been dedicated as highways for all purposes, the ways coloured broken orange on the said plan had been dedicated as restricted byways, the ways coloured broken green on the said plan had been dedicated as bridleways, the ways coloured broken purple on the said plan had been dedicated as footpaths, no other ways had been dedicated as highways over my property.*
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 20th May 2011 referred to in 2. above and at the present time I have no intention of dedicating any more public rights of way over my property.

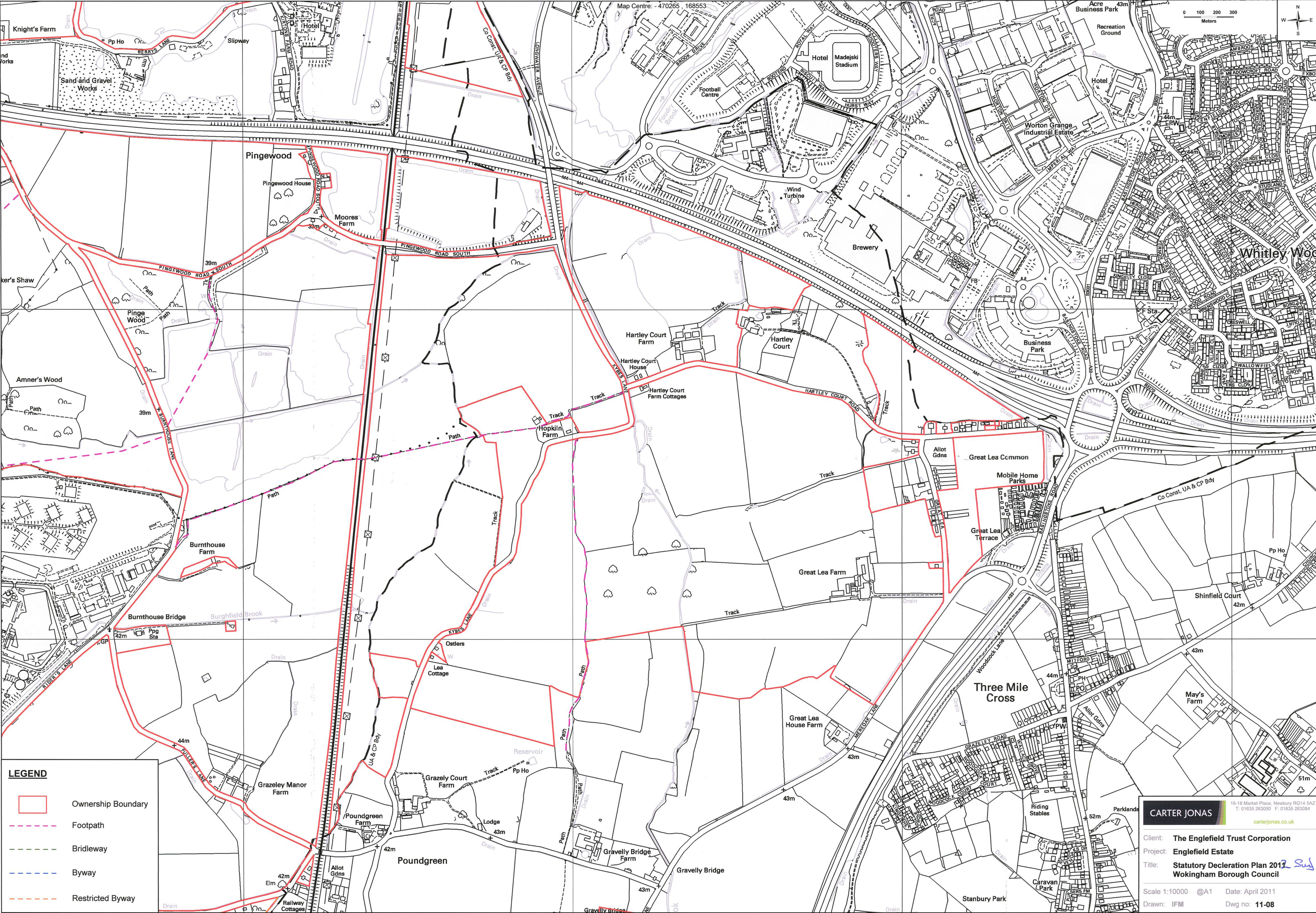
