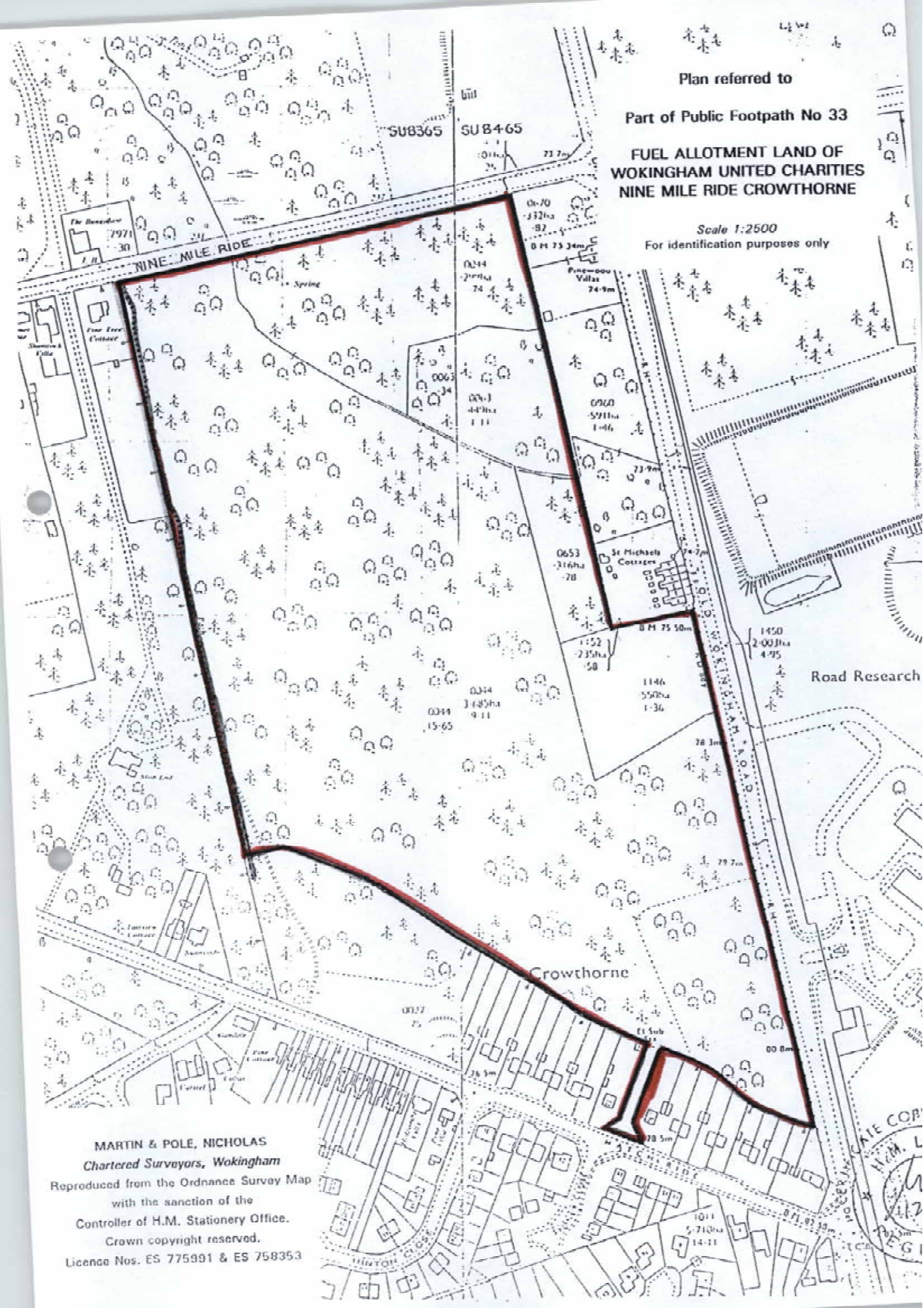

The Official Custodian for Charities as Trustee for and on behalf of Wokingham United Charities is the registered proprietor of land lying between Nine Mile Ride and Old Wokingham Road Wokingham Berkshire registered at H M Land Registry under title No BK198928. A plan of the said land is exhibited hereto and marked "PR 1". The beneficial ownership of the land is held by Wokingham United Charities.
