### **ROAD TRAFFIC REGULATION ACT 1984**

#### **Wokingham Borough Council (Goatley Way, Barkham Road, Broad Street, Station Road, Whitlock Avenue, Wellington Road, Milton Road, Bolton Drive, Gipsy Lane, Murdoch Road, Wokingham) (One Way, Prohibition of Turning, Prescribed Route, Prohibition of Vehicles, No Entry, Bus Gate, 7.5 Tonne Weight Restriction & Keep Left) Order 2024**

### **NOTICE OF PROPOSAL**

NOTICE IS HEREBY GIVEN that Wokingham Borough Council, as the Local Traffic Authority in exercise of its powers under Sections 1(1), 2(1), 2(2), 2(3), 4(1), 4(2), 19, 65(1) and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended, (hereinafter referred to as 'the Act'), Part 6 of the Traffic Management Act 2004, and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act proposes to make the above named Order the effect of which shall be to formalise restrictions on traffic movements along specified routes in the Borough as follows:-

#### **ONE-WAY TRAFFIC**

No person shall except upon the direction of or with the permission of a police constable in uniform, cause or permit any Vehicle to proceed on Goatley Way, Wokingham other than from its junction with Peach Street, in a south-eastward and south-westward direction for its entire length.

#### **PROHIBITION OF TURNING**

No person shall except upon the direction of or with the permission of a police constable in uniform, drive or cause or permit to be driven any Vehicle to make a turn from Barkham Road, Wokingham onto Oxford Road, from Broad Street, Wokingham onto Rose Street, from Station Road, Wokingham onto Station Approach or from Whitlock Road, Wokingham onto A329 London Road.

#### **PRESCRIBED ROUTE**

Every person causing any Vehicle to proceed in a northward direction Wellington Road, Wokingham shall except upon the direction of or with the permission of a police constable in uniform, on reaching the junction with Barkham Road / Station Road cause that Vehicle to proceed ahead only on to Station Approach.

#### **PROHIBITION OF VEHICLES AT ANY TIME**

No person shall, except upon the direction of or with the permission of a police constable in uniform, cause a Vehicle to enter Milton Road, Wokingham from a point approximately 2 metres south of the boundary between Nos.4 / 2 Milton Road, southward for a distance of approximately 4.8 metres unless that Vehicle is proceeding southbound and is a bus of

emergency services vehicle.

### **NO ENTRY**

No person shall, except upon the direction of or with the permission of a police constable in uniform, cause a Vehicle to enter and proceed on Goatley Way, Wokingham from Luckley Path.

### **BUS GATE TRAFFIC RESTRICTIONS**

No person shall use a Vehicle or cause or permit any Vehicle to be in any of the lengths of the Bus Gate in Bolton Drive, Wokingham from a point approximately 45 metres northeast of a point opposite of the extended east kerbline of Bays Crescent eastward for a distance of approximately 14 metres, unless that Vehicle is proceeding eastbound and is a bus, emergency services vehicle or pedal cycle. No person shall use a Vehicle or cause or permit any Vehicle to be in any of the lengths of the Bus Gate in Bolton Drive from a point approximately 59 metres northeast of the extended east kerbline of Bays Crescent, westward for a distance of approximately 19 metres unless that Vehicle is proceeding westbound and is a bus, emergency services vehicle or pedal cycle.

### **7.5 TONNE WEIGHT RESTRICTION**

No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any heavy commercial Vehicle in excess of 7.5 tonnes Maximum Gross Weight to proceed along Gipsy Lane, Wokingham from its junction with Langborough Road for its entire length.

### **KEEP LEFT**

Every person causing any Vehicle to proceed along Murdoch Road, Wokingham in an easterly or westerly direction between its junctions with Howard Road and Crescent Road shall, except upon the direction or with the permission of a police constable in uniform, comply with the Traffic Sign indicating Keep Left.

The above-named Order intends to revoke in its entirety the Wokingham Borough Council (Goatley Way, Barkham Road, Broad Street, Station Road, Whitlock Avenue, Wellington Road, Milton Road, Bolton Drive, Fullbrook Avenue, Gipsy Lane, Murdock Road, Wokingham) (Prohibition of Turning, Prescribed Route, One-Way, Prohibition of Vehicles, Bus Lane, 7.5 Tonne Weight & 6' 6" Width Restriction) Order 2023.
