

ROAD TRAFFIC REGULATION ACT 1984

NOTICE OF PROPOSAL

WOKINGHAM BOROUGH COUNCIL (BEARWOOD ROAD, WINNERSH) (30 MPH SPEED LIMIT) ORDER 2025

NOTICE IS HEREBY GIVEN that Wokingham Borough Council, in exercise of its powers under Sections 81 and 82 of the Road Traffic Regulation Act 1984 (as amended), and of all other enabling powers, proposes to make an order to introduce a 30 miles per hour speed limit on part of Bearwood Road, Winnersh, and to revoke parts of existing speed limit orders as specified below.

Proposals:

- 1. To introduce a 30mph speed limit on Bearwood Road, Winnersh, from a point 10 metres south-east of its junction with Harvest Drive northwards to a point 10 metres south of its junction with Alder Mews. This section of Bearwood Road will become a **restricted road** under the Road Traffic Regulation Act 1984, by virtue of the presence of a system of street lighting, and no further speed limit signage will be required except terminal signs where the restricted road status begins/ends.
- 2. To revoke parts of the following existing orders:
- WOKINGHAM DISTRICT COUNCIL (BEARWOOD ROAD, WINNERSH) (40 MPH SPEED LIMIT) ORDER 1999, insofar as it applies to the section of Bearwood Road from a point 10 metres south-east of its junction with Harvest Drive northwards to a point 10 metres south of Alder Mews. The remainder of the 40mph Order will remain in force.
- WOKINGHAM BOROUGH COUNCIL (VARIOUS ROADS ADJACENT TO SCHOOLS) (VARIABLE SPEED LIMIT) ORDER 2008, in its entirety insofar as it applies to Bearwood Road, Winnersh
