NOTICE OF PROPOSAL

Wokingham Borough Council (Park and Ride Parking Places) (Civil Parking Enforcement) Order 2025

NOTICE IS HEREBY GIVEN that Wokingham Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Sections 1, 2, 4, 32, 33, 35, 37, 38, 39, 46, and 124 and Part III and IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act"), the Traffic Management Act 2004, and all other enabling powers, and in accordance with Section 39(3) of the 1984 Act and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the 1984 Act, proposes to make the above-named Order.

The effect of the Order will be to designate Thames Valley Park & Ride (Maiden Erleigh and Whitegates), Winnersh Park & Ride (Winnersh) and Coppid Beech & Ride (Wescott) as formal Park and Ride parking places within the borough.

The general effect of the Order will be to:

- Revoke in full the Wokingham Borough Council (Park and Ride Parking Places) (Civil Parking Enforcement) Order 2024.
- Designate the following car parks as Park and Ride parking places within the borough for the purpose of civil parking enforcement:
 - **Thames Valley Park & Ride (Maiden Erleigh and Whitegates)**
 - **Winnersh Park & Ride (Winnersh)**
 - **Coppid Beech Park & Ride (Wescott)**
- Incorporate all parking restrictions, terms, and conditions for these sites into a single, consolidated Traffic Regulation Order to improve clarity and enforcement.
- Introduce a barrier control system at the entrance to Thames Valley Park & Ride (Maiden Erleigh and Whitegates). The barrier will be closed overnight between 10:00pm and 6:00am to prevent access during these hours.
- Introduce a release fee payable for vehicles requiring release from Thames Valley Park & Ride when the barrier is closed during these restricted hours
