

#### **ROAD TRAFFIC REGULATION ACT 1984**

# Wokingham Borough Council (Various Off-Street Borough Car Parks) (Civil Parking Enforcement) Order 2023 (Amendment No. 6) Order 2025

**Wokingham Borough Council** ("the Council"), in exercise of its powers under Sections **32**, **35**, **35A**, **35C** and **46** and **Part IV of Schedule 9** to the *Road Traffic Regulation Act 1984* ("the 1984 Act"), as amended, and pursuant to the provisions of *Part 6 of the Traffic Management Act 2004* ("the 2004 Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with *Part III of Schedule 9* to the 1984 Act, hereby makes the following Order:

### 1. Citation and Commencement

This Order may be cited as the Wokingham Borough Council (Various Off-Street Borough Car Parks) (Civil Parking Enforcement) Order 2023 (Amendment No. 6) Order 2025 and shall come into operation on XX XXX 20XX.

### 2. Interpretation

In this Order, "the Order of 2023" means the Wokingham Borough Council (Various Off-Street Borough Car Parks) (Civil Parking Enforcement) Order 2023, as previously amended.

## 3. Amendment of Principal Order

The Wokingham Borough Council (Various Off-Street Borough Car Parks) (Civil Parking Enforcement) Order 2023 is amended as follows:

## (a) In Schedule 1 –

- The entry "Carnival Multi-Storey Car Park and Service Area, Wokingham" shall be amended to reflect the removal of a defined section of service area (as shown on the amended plan) and the addition of a new section of service area.
- The entry "Elms Walk Service Area" is deleted.

## (b) In Schedule 2 -

• The entry numbered 3 "Elms Walk Service Area, Elms Road, Wokingham RG40 2FE" together with its associated provisions is deleted.

### (c) In Schedule 8 -

- The drawing numbered for "Carnival Multi-Storey Car Park and Service Area" (Drawing No. 006) is replaced with an amended drawing to reflect the revised service area.
- The drawing numbered for "Elms Walk Service Area" (Drawing No. 013) is deleted.

## 4. Revocation

Any provision of previous Orders inconsistent with this Amendment is hereby revoked.
