ROAD TRAFFIC REGULATION ACT 1984

WOKINGHAM BOROUGH COUNCIL GRAZELEY VARIOUS (30MPH SPEED LIMIT) ORDER 202*

NOTICE IS HEREBY GIVEN that Wokingham Borough Council ("the Council"), in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (as amended), and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, proposes to make an Order introducing a 30mph speed limit on the roads and lengths specified in Schedule 1.

1. Citation and Commencement

This Order may be cited as the "**WOKINGHAM BOROUGH COUNCIL GRAZELEY VARIOUS (30MPH SPEED LIMIT) ORDER 202***" and shall come into operation on **XXX 20XX**.

2. Interpretation

The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. Revocations

The following existing Orders are hereby partly revoked, insofar as they relate to the lengths of road described in Schedule 1:

- WOKINGHAM DISTRICT COUNCIL (VARIOUS ROADS, SWALLOWFIELD AND SHINFIELD) (40MPH SPEED LIMIT) Order 1999. The remainder of the 40mph Order will remain in force.
- WOKINGHAM BOROUGH COUNCIL (A33 SWALLOWFIELD BYPASS AND VARIOUS ROADS, SHINFIELD) (40MPH SPEED LIMIT) ORDER 2011. The remainder of the 40mph Order will remain in force.

4. Speed Limit

No person shall drive a motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 1 to this Order.

Schedule 1

30mph Speed Limit by Order

ROAD NAME	EXTENTS OF SPEED LIMIT
Lambwood Hill	From a point 30 metres north-east of its junction with Pump Lane, north-eastwards for a distance of approximately 250 metres, to its junction with Grazeley Road
Grazeley Road	From its junction with Mortimer Road, southwards for a distance of approximately 145 metres.
Mereoak Lane	From its junction with Grazeley Green Road, north-east wards for a distance of 85 metres.
Grazeley Green Road	From its junction with Mereoak Lane, north-westwards for a distance of approximately 50 metres.
Mortimer Road	Its entirety.
Church Lane	Its entirety.
Bloomfield Hatch Lane	Its entirety.
