They will only be accepted between 10am and 4pm Monday to Friday (excluding bank holidays) on any day after the date of this notice but must be received no later than **4pm on Thursday, 9th April 2026**.
3. If any election is contested the poll will take place on Thursday, 7th May 2026.
4. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Monday, 20th April 2026**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
5. Applications, amendments or cancellations of postal votes and postal proxy votes must reach the Electoral Registration Officer at Civic Offices, Shute End, Wokingham, Berkshire, RG40 1WH by **5pm on Tuesday, 21st April 2026**. 6. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by **5pm on Tuesday, 28th April 2026**.
