



Allocation breakdown for admission to Secondary School 2026

The following information is based on the initial allocation on 2nd March 2026 for applications received by the deadline of 31st October 2025. This information provides a statement of how places were allocated in line with the published admission arrangements. This information is accurate for National Offer Day but will change once Late applications are considered and responses are received.

Equal preference scheme

Places were allocated using an equal preference scheme. This arrangement allows each preference to be considered individually, taking account of the admissions criteria. Where a child can potentially be offered a place at more than one of the preferred schools the single offer is for the school ranked highest by the parent.

Where the number allocated exceeds the Published Admission Number, this could be due to multiple birth children being allocated to the same setting; a child with an EHC Plan or a looked after/previously looked after child being allocated.

Oversubscription criteria




Wokingham LA student allocation summary

The chart shows the breakdown of applicants who received their first, second, third or fourth preference school and those who were not offered a preferred school. 82% first preference. 11% second preference. 3% third preference. 2 % fourth preference and 2% were not offered a preferred school.

Unsuccessful applications


45 children were unsuccessful in their application for a preferred school. These children were allocated to either their designated area school or most accessible Wokingham school with places available.

The following charts seek to demonstrate factors that will have resulted in this outcome.




Closest designated area school included as a preference

This chart shows that 2 out of 45 applicants who were unsuccessful in their application for a preferred school named their closest designated area school as a preference and 43 did not name their closest designated school as a preference.



Number of preferences

This chart shows the number of preferences per application for applicants who were unsuccessful in their application for a preferred school. Applicants are advised to use all four preferences options. 18 had one preference, 11 had two preferences, 7 had three preferences and 9 had four preferences.



Preference combinations

This chart shows the preference combinations for applicants who were unsuccessful in their application for a preferred school.

7 named other local authority schools only, 1 named other local authority schools and their closest Wokingham DA school, 11 named both other local authority schools and Wokingham schools but did not include their closest designated area school, 1 named all Wokingham schools including their closest designated area school and 25 named all Wokingham schools excluding their closest designated area school.
