**ROAD TRAFFIC REGULATION ACT 1984**

**WOKINGHAM BOROUGH COUNCIL VARIOUS 30MPH  
ORDER 202\***

NOTICE IS HEREBY GIVEN that Wokingham Borough Council, in exercise of its powers under Sections 81,82 and 84 of the Road Traffic Regulation Act 1984 (as amended), and of all other enabling powers, proposes to make an order to extend or introduce a 30mph speed limit on the roads and lengths specified in Schedule 1 and Schedule 2.

**1. Citation and Commencement**

This Order may be cited as the "WOKINGHAM BOROUGH COUNCIL VARIOUS 30MPH ORDER 202\*" and shall come into operation on **xx26**

**2. Interpretation**

In this Order "restricted road" has the same meaning as in Section 82(1) of the Road Traffic Regulation Act 1984.

The maximum speed limit on the restricted road shall be 30 miles per hour.

**3. Restricted Road Declaration**

The lengths of road specified in Schedule 1 shall become restricted roads for the purposes of Section 81 of the Road Traffic Regulation Act 1984 by virtue of the presence of a system of street lighting furnished by means of lamps placed not more than 183 metres apart

**4. Revocations**

The following existing Orders are hereby revoked insofar as they relate to the lengths of road described in Schedule 1:

**ROYAL COUNTY OF BERKSHIRE (RESTRICTED ROADS AND 40MPH SPEED LIMIT) (NEW ROAD, NORTHBURY AVENUE AND ST JAMES CLOSE, RUSCOMBE (NO4) ORDER 1985.** The remainder of the 40mph Order will remain in force.

**6. Speed Limit**

No person shall drive a motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 1 and Schedule 2 to this Order.

**Schedule 1 - Restricted roads under Section 82**

ROAD NAME	EXTENTS OF SPEED LIMIT
Biggs Lane, Arborfield	From its junction Commonfield Lane, north-westwards for a distance of approximately <b>50 metres.</b>

**Schedule 2 - Explicit 30mph Order under Section 84**

<b>ROAD NAME</b>	<b>EXTENTS OF SPEED LIMIT</b>
<b>Park Lane, Finchampstead</b>	From a point approximately <b>25 metres</b> north-east of its junction with Palmer Place, northwards to its junction with Commonfield Lane.
<b>Stanlake Lane, Twyford</b>	From its junction with the B3024, southwards for a distance of approximately <b>50 metres</b> .
<b>Waltham Road, Twyford</b>	From its junction with New Road and Stanlake Lane, east-wards for a distance of approximately <b>65 metres</b> .
<b>New Road, Twyford</b>	From its junction with the B3024, northwards for a distance of approximately <b>30 metres</b> .
