Charges for burial in any grave or vault are tripled for people who did not live in the Borough of Wokingham at the time of their death. <sup>3</sup>

If the person paying for the funeral is receiving any means tested benefits, they may be able to claim financial help from The Social Fund.

Ashes grave digging and burial attendance (self-directed burials only and fee to be added to Exclusive Rights and Interment Fee)	£300.00

## Notes

1. Exclusive Rights **and** Interment fee, payable on first new burial. Interment fee excludes grave digging fee.
2. Fees can be reclaimed through the Children's Funeral Fund.
3. Resident grave purchase fees based on permanent address of deceased. Non-residents arranging the interment of Wokingham resident following death will qualify for Wokingham resident fees. Applies to first interment only, second and subsequent interments as per resident's fee.
4. A memorial permit must be obtained before any memorial is installed or modified in a cemetery. Permit fee covers administration and memorial safety inspections by cemetery.
